Executive Summary

The curated text messages document ongoing disputes between the device owner and the contact (+15551110002) regarding child custody, visitation logistics, financial obligations, and personal conduct. The communications show recurring disagreements over handoff times, which the device owner states have led to missed appointments, as well as discussions regarding the contact's alcohol consumption and the child's safety during parenting time. Additionally, the messages highlight financial tensions, including disputes over outstanding payments, the division and sale of joint property, and statements by the contact indicating they will stop paying for school activities if supervised visitation is pursued. Throughout the exchanges, the contact expresses warnings regarding litigation, emergency custody filings, and personal repercussions.

Key Themes

Disputes Over Financial Support. The messages show disagreements regarding outstanding payments, the sale and division of a boat, and threats to stop paying for extracurricular activities in response to custody adjustments. ^{[1][2][3][4][5][6][7]}

Scheduling Conflicts and Co-Parenting. The device owner notes repeated late arrivals causing missed appointments, while the contact demands detailed tracking of the child's schedule. ^{[8][9][10][11][12]}

Concerns Regarding Alcohol Use. The exchanges detail discussions regarding the contact's alcohol use during parenting time, an incident involving an unlocked door, and requests for supervised visits. ^{[13][14][15][16][17][18]}

Warnings of Court Action. The contact issues multiple warnings regarding returning to court, filing for emergency custody, and personal consequences. ^{[19][20][21][22][23][24]}
